

## Visitation Policy

This visitation procedure updated and effective 4/14/2022 is the most current of procedures. This policy and procedure has been updated according to “No Patient Left Alone Act” and encompasses all requirements of 408.823.

- At AdviniaCare Skilled Nursing, Paddock Cove and Paddock Ridge, Pointe Group communities all visitation is allowed and does not limit the number of visitors, or length of visits. We encourage the families and friends of our residents to continue to visit providing much needed social interaction for our resident’s wellbeing.
- We ask that if a visitor is feeling ill, has a fever that is at or above 100.4, or symptoms that are cold related please do not visit your loved ones until symptoms subside or you have had no fever for 24 hours.
- Consensual physical contact with our residents and their family and friends is not only allowed but encouraged.
- Upon arrival to our facility, you will be asked to screen in, sign our visitor log, your temperature will be taken, and you will answer some basic questions. Upon exiting we ask that you check out at the same reception area.
- This facility does ask that you limit your time in common areas and continue to visit in your loved one’s rooms, in one of our outdoor patios or we can make available dining area for you and your loved as they are available.
- Hand sanitizer is located at the front desk and around our facility, we ask visitors to sanitize their hands upon entry and exit and you are encouraged to clean your hands regularly while visiting the facility.
- PPE is always available for our visitors from standard surgical masks to gowns, and gloves if a situation calls for use of additional usage of PPE.
- The facility will notify all residents and family members in the event the facility experiences a Covid-19 infection and/or Outbreak. In this event

visitors may be asked to visit loved ones in room only and additional PPE may be required.

- This facility does reserve the right to deny visitation to individuals who refuse to follow our guidance, for the safety of residents and staff.
